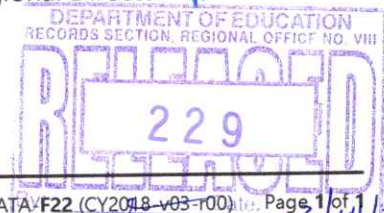
**SUBMISSION OF THE DIVISION DATA ON THE SPECIAL PROGRAM FOR SCIENCE,

3. The scheduled deadline is set to facilitate consolidation and validation of the data and the submission of the Regional Report to the Office of the Undersecretary for Curriculum and Instruction, through the Bureau of Curriculum Development.
