Greetings from Resources for the Blind, Inc.!

Resources for the Blind Inc., (RBI), a non-government organization devoted to removing the obstacle and providing the services, trainings, materials, and equipment needed in order for blind Filipinos to reach the fullest potential in life and ministry that God has for them for 35 years now.

Our office in partnership with the Department of Education has actively collaborated in the summer training program for SPED teachers on Visual Impairment nationwide since 2000 up to 2017 in partnership with CNU-USEP-PNU. In partnership with CBM, provided a Resource room for SPED VI after Typhoon Haiyan in selected schools with SPED program in the region and other areas in Visayas. Also, we provided technical support to the trained SPED teachers, upgrade training, equipment needed in the SPED program and training & development for our students with visual impairment such as computer training, orientation and mobility, leadership training, and other blind skills training appropriate for them. Furthermore, we are in our 5-year Program on Inclusive Eye Health in partnership with the IEH Cluster- Department of Health Region 8, Eye Hear Foundation, Inc. and CBM in 2019-2023. For the current status of the program, we were able to provide low vision intervention to 1,547 students with disabilities in schools of region 8 and nationwide, dispensed 586 spectacles and low vision devices needed for the students to cope up with the daily activities in school for near and distance task. In addition, referred 899 persons with permanent blindness needing other services appropriate for them.

In line with this, we, RBI and the rest of the team in the Inclusive Eye Health Cluster, Department of Health Region 8, Eye Hear Foundation, Inc. together with CBM Global Country Director, Mr. Hercules Paradiang, Program Manager Mr. Genaro Sanchez, and the CBM Australia Program Coordinator Mr. Patrick Makenen is glad to visit your good office. The visit is scheduled on April 20, 2023 in the afternoon for your reference. The purpose of the visit is to know possible:

- Updates on accomplishments through the collaboration with RBI on inclusive eye health and other programs and services for persons with visual impairment.

  - 2. What are the agreements, mechanisms, or processes already in place?

- What possible recommendations the DepEd can think of to better serve the children in schools with eye health services.
