1. Pursuant to sentence 01, paragraph 01 of DepEd Order No. 26, s. 2002, re: ENJOINING COMPLIANCE to DECS ORDER NO. 120, s. 1999 – Amending Certain Provisions of DECS Order No. 13, s. 1998, reads “ The State shall, in conformity with the mandate of the constitution, encourage and promote the teaching of religion to children in public elementary and high schools within the regular class hours.” Hence, conduct of religion class in schools is allowed provided that all provisions in D.O. No. 26, s. 2002 is strictly observed (see enclosure).

2. The school principal or school head must take full responsibility in arranging the schedule of the religion classes upon request of the parents or guardians. Religion class is separate from Edukasyon sa Pagpapakatao (EsP) period and schools who opt to request conduct of religion classes shall be evaluated by the office through Curriculum Implementation Division (CID) in coordination with the Curriculum & Learning Management Division (CLMD) of the regional office ensuring that provisions relative to its implementation are strictly followed.

3. School principals/heads must communicate to the Division office on the status of the conduct of Religion Classes at least 2 weeks before the end of every quarter.

4. Compliance with and widest dissemination of this MEMORANDUM are highly desired.

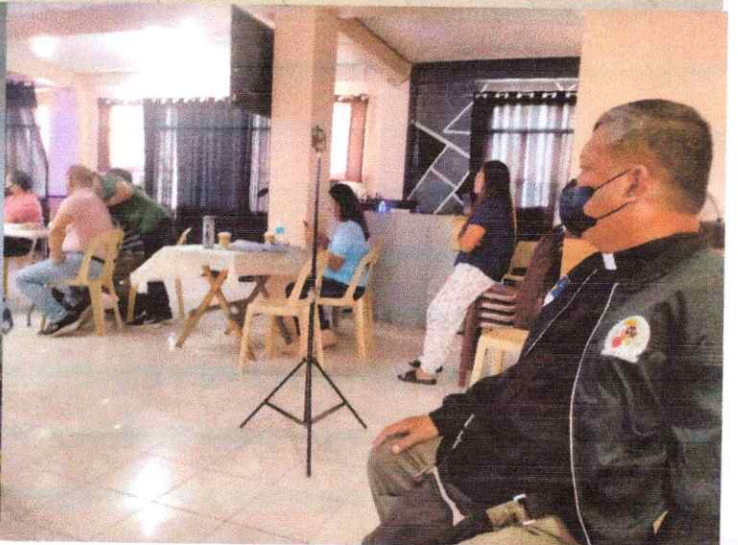
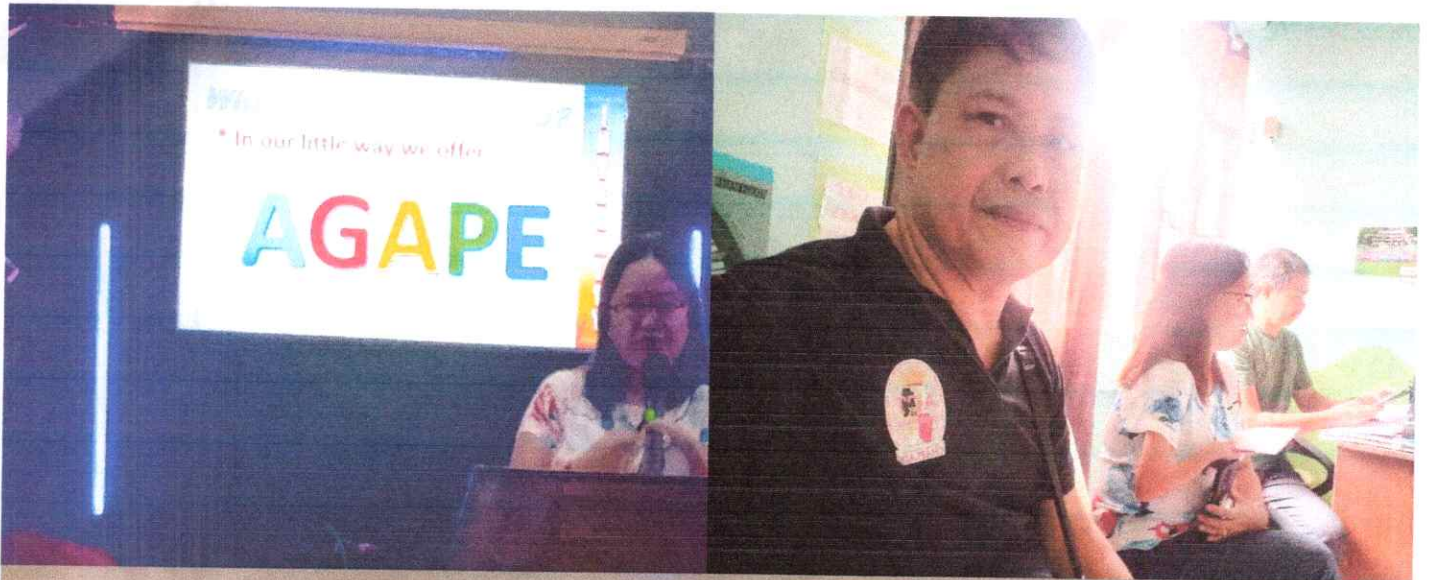

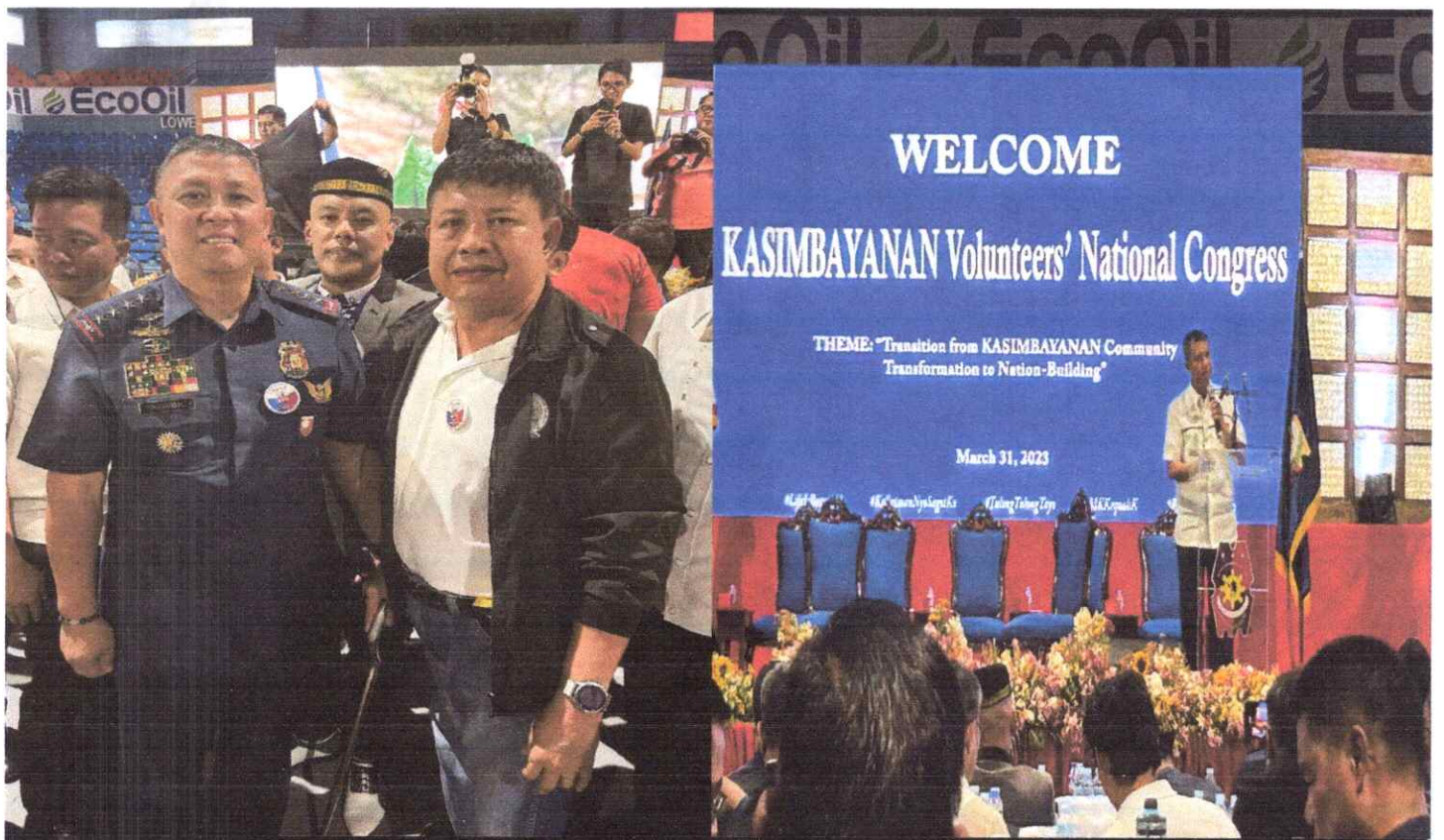
