CONDUCT OF QUARTER 2 FINANCE GROUP CONFERENCE

To: Schools Division Superintendents Regional Office Division Chiefs All Others Concerned

- 1. This Office, through the Finance Division, shall hold its **Quarter 2 Finance** Group Conference on May 17-19, 2023, at a venue to be announced later.
- 2. The expected participants in this activity are the following:
 RO: Finance Division Unit Heads, Accounting and Budget Personnel
 SDO: Accountants, Budget Officers, and 1 SDO staff in charge of consolidating
 AOM, NS, and ND compliance updates (3 participants per SDO).
- 3. The topics to be discussed are as follows:
 - Reporting on the Status of Implementation of Downloaded Funds to SDOs by SDO Budget Officers;
 - b. Validation and submission of NOA, NTP, Contracts/PO, and Statement of Expenditure (SOE) per Sub-ARO and submission of documentary requirements to support the SOEs;
 - c. Preparation of Action Plans on Unliquidated Fund Transfers to SDOs;
 - d. Updating and Reporting on the Consolidated SDO Status of Agency Action Plan and Status of Implementation of CY 2022 and Prior years' AOMs, ND, and NS as of April 30, 2023, by the Division Accountants;
 - e. Validation and submission of SASDCs, Validated AAPSI, and NSSDCs;
 - f. Other financial issues and concerns.
- 4. Moreover, participants are expected to bring their own laptops, extension wires and back-up pocket wifi, and necessary documents for submission as cited above.
- 5. No registration fee shall be collected from each participant. Funds to defray the cost of meals and lodging of participants shall be charged to RO-Finance Division Funds. Traveling expenses of participants shall, however, be charged to their respective SDO MOOE, subject to the usual accounting and auditing rules and regulations.
- 6. Further, all concerned are directed to strictly observe IATF protocols appropriate for the activity.
