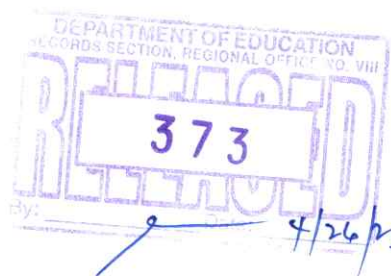
- b. Current Language Education Policies;

 - d. Teaching and Learning Resources;
 - e. Assessment of Learning; and
 - f. Program Delivery/Monitoring and Evaluation.
4. The SDO presentation must be submitted on or before April 28, 2023 to give time for consolidation and video packaging of the Regional Presentation to be shared during the said activity.
5. In order to come up with a more engaging and captivating Regional Video Presentation, this Office requests the expertise of Mr. Junrell R. Lora, Teacher, Alegria-Batuan Elementary School, Ormoc City Division.
