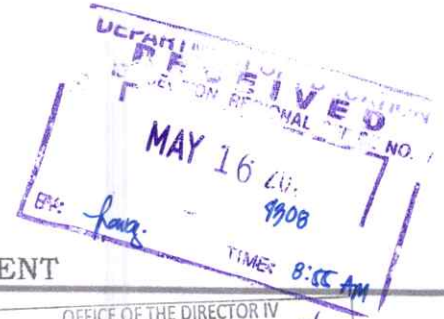

SUBJECT : **COMPREHENSIVE RAPID LITERACY ASSESSMENT (CRLA) DEVELOPMENT WORKSHOP**

DATE : May 10, 2023

In line with the efforts of the Department of Education to provide solutions to the perennial problem with literacy faced by the country, the Bureau of Curriculum Development in partnership with ABC+, shall conduct the **CRLA Development Workshop**. The activity aims to develop assessment tools for 10 mother languages and their respective variations, which shall serve as pre-assessment for the Learning Camp Reading Program. The activity shall be conducted via two parallel workshops on **May 22 to 26, 2023**: the Luzon cluster shall be held in a venue in Cabanatuan City; and the Mindanao cluster shall be held in a venue in Zamboanga City.

In line with this, DepEd Personnel who teach K-3 in the following languages shall serve as test item developers during the workshop. We request that the Regional and Division Offices prioritize those who have served as part of the Mother Tongue Primer Development Team.
