- 1. The participants of the aforesaid activity are the CLMD Chief, Regional and Division Focal Persons of the different event categories, Technical Working Group (TWG) of the Host Division headed by the Schools Division Superintendent, officials/representative of the Local Government Units (LGUs) from the municipality or barangays where the contest venues and billeting schools are located, and invited representatives of other partner agencies that provide essential services such as security, water, electricity, and internet.
- 4. Travelling and other incidental expenses incurred by the Regional TWG members shall be charged to the CLMD Local Funds while those of the Division


