1. The Department of Education, Regional Office No. VIII, through the Quality Assurance Division (QAD) announces the **closure** of the **General Academic (GA) and Technical Vocational Livelihood (TVL) tracks** of the Senior High School (SHS) curricular offerings of **Divine Mercy Integrated Academy of Villareal Foundation, Inc.** of Brgy. Soledad, Villareal, Samar with the School ID No. 409263 and Provisionary Permit SHS No. 004, s. 2019. Based on the communication received from the School Principal endorsed by the Schools Division Superintendent of Samar Division, the above-cited curricular offerings of the said school have a very minimal number of enrollees for the last four school years resulting to a decision for its voluntary closure. Thus, **the provisional permit to operate the said offerings is hereby revoked.**

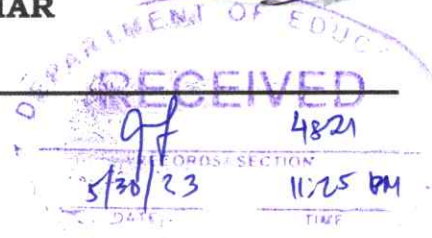


Warm Greetings!
