The Bureau of Alternative Education (BAE), in partnership with the United States Agency for International Development (USAID) - Education Development Center (EDC) through SEAMEO INNOTECH, conducted an orientation for the pilot implementation of the Alternative Learning System (ALS) Monitoring and Evaluation (M&E) System in April and May 2023.

As agreed during the orientation, pilot divisions are required to submit a copy of the approved Regional Education Development Plan (REDP), Division Education Development Plan (DEDP), 2023 Annual Implementation Plan (AIP) of CLC and Division ALS Program AIP before the end of June 2023. Additionally, pilot divisions should submit the consolidated 2022 mapping results of the municipal and division levels, which shall serve as the division's baseline data.

To discuss the progress and to provide additional technical assistance, the BAE-Policy and Quality Assurance Division (PQAD) will hold meetings with the pilot divisions' implementors via MS Teams on the following dates, times, and links, respectively.
