The Department of Education, Regional Office No. VIII through the Quality Assurance Division (QAD) announces the **CLOSURE OF NORTHERN EAST SAMAR ACADEMY, INC.** San Policarpo, Eastern Samar Division, Region VIII with **School ID No. 404748 and GR No. 024, s. 2002** effective SY 2023-2024. The closure of the said school is through the voluntary withdrawal of permit under Section 43 of DepEd Order No. 88, s. 2010 per communication received from **Dr. Gorgonio G. Diaz, Jr., Ph.D., CESO V**, Schools Division Superintendent, Eastern Samar Division with the following reasons, to wit:
  - a. Insufficient fund for school's operation;
  - b. No available teachers and staff;
  - c. Learners were forwarded to the nearest public secondary school (SNPOSA), and
  - d. The members of DREC provided technical assistance last March 21, 2023, but no action taken to date by the school.
2. The Schools Division Superintendent is hereby empowered to facilitate the safekeeping and repository/archive of all the pertinent documents following the guidelines stated in DepEd Order No. 88, s. 2010, Section 154, Custody of Student Records.
