

## **Proposed Policy Implementation Review Guide Questions**

- 1. Did the policy address the problem or gaps? What problems or issues did the policy address?
- 2. Are the scope and duration of the policy still relevant? If not, what makes the scope and duration of the policy irrelevant?
- 3. Did the policy achieve its objectives? If not, what factors hindered its implementation or operationalization?
- 4. What problem areas have not been covered and addressed by the policy?
- 5. Is there consistency or conflict of the policy with existing issuances? What issuances are related to having covered the same problem over the past five vears?
- 6. Is the policy still relevant? What makes it or not relevant? Describe the strengths and weaknesses of the policy.
- 7. Is this policy or procedure being followed properly? Why are implementers unable to follow or implement the policy?
- 8. Are implementers oriented or trained on the policy or procedure? What do implementers not know about the policy?
- 9. Is the policy relevant based on current research literature and the current demands of the Department?
- 10. How can the policy implementation be strengthened in the duration of its implementation?
- 11.Is the progress monitoring and evaluation mechanism of the policy comprehensive? Are the expected outputs described? Are the success indicators identified? Is the timetable and feedback mechanism established?
- 12. What policy recommendations or alternatives can be proposed or considered based on the current gaps in the policy?
