**CONDUCT OF DIVISION TRAINING OF TRAINERS AND MASS TRAINING
OF KEY STAGE 1 TEACHERS AND OTHER RELATED ACTIVITIES
ON THE IMPLEMENTATION OF THE LEARNING
RECOVERY CURRICULUM (LRC)**

To: Schools Division Superintendents
All Others Concerned

1. Relative to Regional Memorandum No. 843, s. 2023 on the conduct the Development and Quality Assurance of Materials Cum Regional Training of Trainers on the Implementation of the Learning Recovery Curriculum (LRC) on August 13-20, 2023, this Office, through the Curriculum and Learning Management Division (CLMD) requires all the Schools Division Offices (SDOs) to facilitate the conduct of the Division Training of Trainers and Mass Training of Key Stage 1 Teachers with the timeline given below:

Activity	Date
Division Training of Trainers	August 23-25, 2023
Training of Key Stage 1 Teachers	August 31-September 1&2, 2023
Orientation of Instructional Leaders	September 8, 2023

2. It is expected that there shall be a comprehensive orientation and proper coordination among the division personnel, instructional leaders, and other stakeholders for wider participation and stronger support; thereby, ascertaining successful implementation of the LRC.

3. The SDOs, through the Curriculum and Implementation Division (CID) Chiefs and the Literacy and Focal Persons, shall facilitate the preparations and procurement, if needed, for the conduct of the trainings and orientations.

4. Since the LRC is in support of the National Learning Recovery Program (NLRP), expenses for the board and lodging during the trainings and orientations to include the materials for the worksheets, manipulative materials, literacy and numeracy stations, laminating machine and films, consumables for printing, and other related expenditures shall be charged against the declared excess amount of the downloaded funds per DepEd Memorandum DM-CT-2023-167 on the Guidelines on the Utilization of Support Funds to the Regional Offices for the Resources and Worksheets of End-of-School-Year (EOSY) Reading for Grades 1 to 3.



Resources and Worksheets of End-of-School-Year (EOSY) Reading for Grades 1 to 3. Local Funds (Division/School MOOE) may also be utilized, subject to the usual auditing rules and regulations.

5. Immediate dissemination of and strict compliance with this Memorandum are desired.
