- a) For research: Background and Rationale; Research Questions; Methodology & Research Design; Summary of Results; Conclusion & Recommendations; and References.
- b) For innovations: Rationale; Procedure (Key innovative features, including the persons involved, locale, resources, and cost of the project); Impact to the School and Community; and Next Steps.

	o The presenter gives a clear and concise discussion.	
	o Knowledge on and mastery of the subject is evident when answering	
	the questions or in responding to feedback.
