Rebolledo-Del Rosario St. Carigara, Leyte, Division of Leyte with **School ID No. 404666, and GR No. 05 s. 1997-Elementary** for SY 2023-2024. The closure of classes of the said school is through the voluntary withdrawal of permit under Section 43 of DepEd Order No. 88, s. 2010 per communication received from **Dr. Mariza S. Magan, CESO V**, Schools Division Superintendent, Leyte Division with the following reasons as cited by the OIC acting School Director **Ms. Rachel Clarissa Clenia M. Candaza**, to wit:
 - a. Reorganization of physical structures of the school; and
 - b. Unavailability of buildings where Grades 1 to 6 classes are conducted.

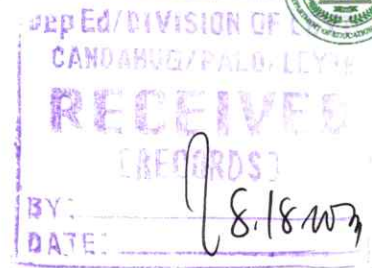
