MONITORING AND EVALUATION ON THE IMPLEMENTATION OF PROJECT KEY STAGE 1 FOUNDATIONS FOR EFFECTIVE LEARNING TRANSITION (K-3 FELT)

To: Schools Division Superintendents All Others Concerned

- 1. This Office, through the Curriculum and Learning Management Division (CLMD) with the support of the United Nations Children's Funds (UNICEF) and the Advancing Basic Education in the Philippines (ABC+), shall conduct monitoring and evaluation on the implementation of Project Key Stage 1 Foundations for Effective Learning Transition (K-3 FELT) on October 16-27, 2023.
- 2. The activity aims to:
 - a. determine the extent of implementation of Project K-3 FELT whether it is at par with standards using the available monitoring and evaluation tools;
 - b. conduct instructional coaching sessions to teachers as a way of providing technical assistance;
 - c. track learners' progress in literacy and numeracy; and
 - d. document good practices, challenges, and enhancements which serve as inputs on possible adjustment of the project implementation in the succeeding school years.
- 3. The Schools Division Offices are expected to:
 - a. orient all division personnel, public school district supervisors, and school heads on the different M&E tools and instructional coaching:
 - ascertain that all Key Stage 1 teachers are likewise oriented on the M&E Tools;
 - c. organize M&E Teams composed of CID/SGOD Chief and Division EPS as leader and PSDSs as members;
 - d. deploy the organized teams making sure that the PSDS who belongs to the team shall be assigned to another district;
 - e. randomly select schools covering ten (10) percent as sample of the total school population within the division;
 - f. ascertain that all school types, grades levels (Grades 1 -3), and learning areas are selected in the class observation;
 - g. conduct instructional coaching after the class observation; and
 - h. facilitate the accomplishment of the learner' progress tracking and survey forms.
