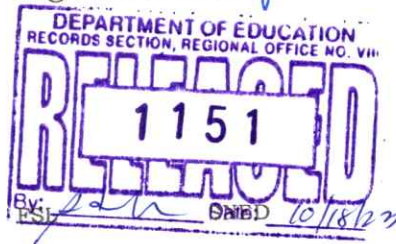
**PARTICIPATION TO THE CONSULTATIVE CONFERENCE ON THE


