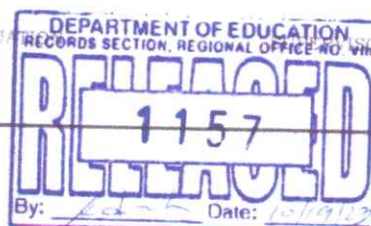
To: Schools Division Superintendents

2. This activity aims to:
 - a. make a report of the significant experiences as regards contest procedures including challenges encountered during the conduct of the 2023 Regional Festival of Talents (RFOT) and participation to the 2023 National Festival of Talents (NFOT);
 - b. discuss the promotion of widening the base of talent identification and selection in school/district/division;
 - c. revisit established interventions to achieve the desired impact in showcasing the learners' talents and skills in the future conduct of both RFOT and NFOT; and
 - d. discuss other related matters.
3. The participants of the aforesaid activity are the Chief and Education Program Supervisors (EPSs) of CLMD, Division Education Program Supervisors (EPSs) in MAPEH & TLE, and CID Chief of Catbalogan City Division being the host of the next year Regional Festival of Talents.
4.
