In reference to the OUOPS Memorandum No. 2023-04-10050 with the subject: *Conduct of the 2023 National Climate Change Conference and the 2023 National DRRM Year-end Evaluation and Planning Workshop* on November 21, 2023, Tuesday, the Disaster Risk Reduction and Management Service (DRRMS) would like to inform all invited resource speakers, panelists, participants, and guests that the agency is monitoring a Low-Pressure Area (LPA) located at 1,620 km. east of southeastern Mindanao that possible to redevelop into a Tropical Cyclone, based on the Advisory issued by the DOST-PAGASA on 14 November 2023, 5:00 AM. According to the report, the weather system is forecast to accelerate towards the west or west-northwestward. It may enter the Philippine Area of Responsibility (PAR) region late tomorrow or early Thursday. Within the PAR, this weather system will continue tracking westward until Friday while slowly intensifying. A more northwestward turn during the weekend over the waters east of Mindanao.

With this, the DRRMS hereby decides the shift of modality for the conduct of the 2023 National Climate Change Conference. The event will be held online with live streaming on Facebook. Further, the event which was originally scheduled for 21 November 2023 will be postponed to 13 December 2023.

While we understand the inconvenience this may cause especially on the travel arrangements that have already been booked, the safety and well-being of everyone involved are of utmost importance.
