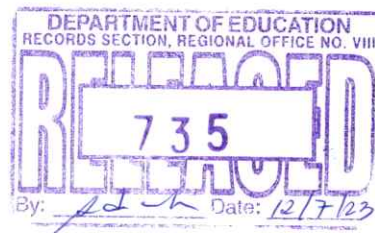

2. The specific schedules are stipulated in the table below.

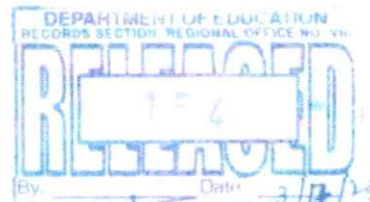
First Quarter	March 30, 2023
