**REORGANIZATION OF THE REGIONAL FIELD TECHNICAL ASSISTANCE
 CORE AND COMPOSITE TEAMS (RFTACT) OF DEPED REGION VIII**

To: Schools Division Superintendents
 Regional Office Division Chiefs
 All Others Concerned

1. To further intensify and strengthen Technical Assistance provision to Schools Divisions throughout the Region for the improvement of learning outcomes despite the retirement/promotion/transfer of some members, DepED Regional Office VIII through the Field Technical Assistance Division (FTAD), hereby informs the field of the **Reorganization of the Regional Field Technical Assistance Core and Composite Teams (RFTACT)** and their Schools Divisions assignment (*see attached list*).
2. The Technical Assistance Providers shall perform the following roles and functions:
 - a. Provide support, coaching and guidance to clients in the performance of their functions;
 - b. Utilize the results on the DEDP implementation, Regional Quality Management Team (RQMT) Report, EBEIS Data, and Performance Improvement Review (PIR) Results in planning or preparing a Technical Assistance (TA) plan;
 - c. Regularly appraise clients on the status of their performance and to do their functions;
 - d. Provide necessary information to the clients in the performance of their functions more effectively;
 - e. Provide motivation and encouragement to move forward and for continuous improvement; and
 - f. Utilize data gathered in the preparation of recommendations for policy formulation.
3. During RFTACT deployment, if the identified TA provider of the team fails to join due to valid reasons, an alternate member or any member of the other teams coming from the identified Functional Division can replace him/her. As such, the team shall be a **Flexi RFTACT**.

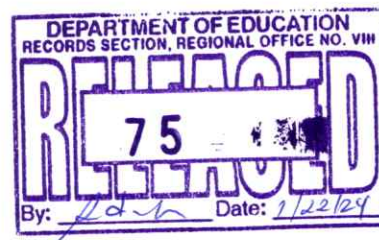
