RECOMMENDATIONS

In view of the foregoing evaluation and findings, the team respectfully recommends that:

- The school shall be named Hinabuyan National High School and is authorized to operate effective School Year 2024-2025;
- 2. The opening of the newly established school shall be on a gradual basis; the Curriculum Grades to be offered upon the opening of classes for School Year 2024-2025 should only be Grade 7. The progression of its expansion for the following grade levels in junior high school shall depend on the availability of the required resources upon approval of the Schools Division Superintendent.
- The Schools Division Superintendent (SDS) of Leyte shall provide teachers trained on the K to 12 Curriculum for the establishment of Hinabuyan NHS specifically major in English, Mathematics, Science (Biology, Physics, Chemistry, General Sciences), Filipino, Araling Panlipunan, and MAPEH;
- The construction of the school building and other structures shall strictly be compliant with the recommendations stipulated in the certification given by the Mines and Geosciences Bureau;
- The Schools Division Office shall likewise provide school buildings, chairs, textbooks, and other resources to the newly established school; and
- The School shall be considered in the budget preparation for its eventual inclusion in the immediate succeeding General Appropriation Act (GAA).

EVALUATION AND RECOMMENDATION REPORT OF SCHOOL'S APPLICATION

Name of School

: HINABUYAN NATIONAL HIGH SCHOOL

School Address

: ESTABLISHMENT OF JUNIOR HIGH SCHOOL

FINDINGS:

1. There are two (2) available classrooms in the proposed school that can be utilized for Grade 7 with an ongoing construction of one building with four classrooms from the Local Government Unit;

- 2. The school site has an area of 10,000 square meters with a Deed of Grant of Usufructuary Right signed by Dr. Manuel P. Albaño, Schools Division Superintendent and Hon. Mayor Jorge V. Veloso;
- 3. The school has obtained a certification from the Mines and Geosciences Bureau certifying that the school site is located in Hinabuyan, Villaba, Leyte, and is classified as having a High Landslide Susceptibility Rating;
- 4. There are four catchment barangays, as reflected in the feasibility study submitted;
- 5. The school is conducive to learning, as the site is free from noise, unpleasant odors, and distractions;
- The school has no laboratories and perimeter fence to define the school boundaries, but it has buildable space for possible expansion of curricular offerings in the succeeding years;
- 7. The Municipal Local Government Unit pledges financial assistance to cover all school-related expenses. This includes constructing new school buildings, procuring educational facilities, furniture, instructional materials, and maintenance for at least five years or until funds for these purposes are allocated in the National Budget.
- 8. The Schools Division Superintendent of Leyte Division commits through a Memorandum of Agreement with the Municipal Local Government Unit to work for the school's funding requirements for Personnel services and Other Operating Expenses; and
- 9. The Schools Division Superintendent shall ensure the designation of Officer-In-Charge of the school.
