

Fifteen DepEd Regional Offices (ROs) underwent a third-party audit to sufficiently evaluate whether they are certifiable to ISO 9001:2015 standards. These ROs are Region I, II, III, IV-B, V, VI, VII, VIII, IX, X, XI, XII, CARAGA, CAR, and NCR.


The Stage 1 audit, conducted on February 5-9, 2024, focused on the document review and the preparedness of the ROs for certification. Meanwhile, last February 19 – March 1, 2024, the Stage 2 audit assessed the implementation of the established quality management system based on the standards.

Thus, during the online grand closing meeting held last March 6, 2024, the certifying body, TUV Nord Philippines, Inc., recommended these DepEd Regional Offices for ISO 9001:2015 Certification as deemed compliant with the requirements of the standards.
