EVALUATION AND RECOMMENDATION REPORT OF SCHOOL'S APPLICATION

Name of School : DOOS DEL NORTE NATIONAL HIGH SCHOOL

School Address : BRGY. DOOS, HINDANG, LEYTE

Type of Application : ESTABLISHMENT OF SECONDARY SCHOOL

FINDINGS:

- 1. The proposed school has an existing school site of 9,000 sq.m. out from Doos Elementary School site of 17,410 sq.m. through a Memorandum of Understanding of both parties attested by the Schools Division Superintendent as proof of school site ownership;
- 2. There are four vacant classrooms in the Doos Elementary School which can be utilized temporarily by the proposed Doos National High School while waiting for the implementation of the 10 million classroom budget allocation from the Department of Education for Calendar Year 2024;
- 3. The identified secondary schools are far from the proposed Doos National High School with the following distance as follows;
 - a) Hindang NHS 2.8 kms.
 - b) Bontoc NHS 1.9 kms.
- 4. The community of the proposed school was able to provide a temporary fence at the actual school site;
- 5. The school is conducive to learning, as the site is free from noise, unpleasant odors, and distractions;
- 6. The school site has buildable space that can cater to the expansion of curricular offerings in the future.;
- 7. The Local Government Unit pledges its financial assistance to cover all school-related expenses: This includes constructing new school buildings, procuring educational facilities, furniture, instructional materials, and maintenance for at least five years or until funds for these purposes are allocated in the National Budget;
- 8. The Schools Division Superintendent of Leyte Division commits to work for the school's funding requirements for Personnel services and Other Operating Expenses; and

 The Schools Division Superintendent shall ensure the designation of Officer-In-Charge of the school and provide teaching and non-teaching personnel to the proposed school while the Plantilla of Personnel is still in process for approval.

RECOMMENDATIONS

In view of the foregoing evaluation and findings, the team respectfully recommends that:

- The secondary school shall be established and named DOOS DEL NORTE NATIONAL HIGH SCHOOL and is authorized to operate effective School Year 2024-2025;
- 2. The opening of the newly established school shall be on a gradual basis, the Curriculum Grades to be offered upon opening of classes for School Year 2024-2025 shall only be Grades 7 and 8. The progression of its expansion for the next grade levels shall depend on the availability of the required resources upon approval of the Schools Division Superintendent.
- 3. The Schools Division Superintendent (SDS) of Leyte Division shall provide teachers trained on the K to 12 Curriculum;
- 4. The construction of the school building and other structures shall strictly be compliant with DepEd School Building Standards.
- 5. The Schools Division Office shall likewise provide school buildings, chairs, textbooks, and other resources to the newly established school; and
- 6. The School shall be considered in the budget preparation for its eventual inclusion in the immediate succeeding General Appropriation Act (GAA).


