- Attached is DM-CT-2024-113 dated April 17, 2024 requesting the Regions and Divisions to submit list of schools that could be included in the expansion of the Inclusive Learning Resource Centers (ILRCs) for FY 2025 thru conversion or new construction.
- Since the Region has already identified one potential SPED Center or school implementing the SPED Program that meets the criteria stipulated in DO 45, s. 2021 under the new construction scheme, the Schools Divisions which are yet to have their ILRC are requested to nominate a potential school that can be considered under the conversion mode for FY 2025.
- Both the identified school in the construction scheme (Kananga I Central School) and the yet-to-be-identified school under the conversion mode are advised to comply with the needed documents and submit through **clmd.region8@deped.gov.ph** on or before April 30, 2024.
- Immediate dissemination of and compliance with this Memorandum are desired.

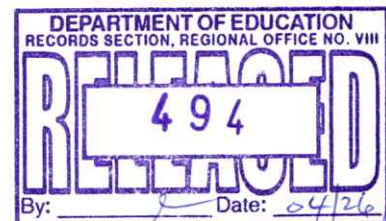

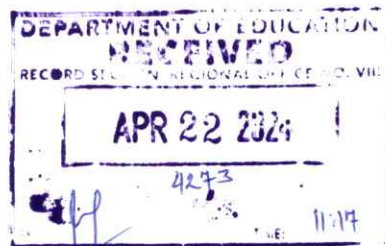

SUBJECT : **SUBMISSION OF NOMINATION DOCUMENTS FOR THE EXPANSION OF INCLUSIVE LEARNING RESOURCE CENTERS (ILRCs) FOR FY 2025**

DATE : April 17, 2024

In line with the implementation of Republic Act (RA) No. 11650, *Instituting a Policy of Inclusion and Services for Learners with Disabilities*, and the Department of Education's (DepEd) MATATAG Education Agenda to **TAke** good care of learners by promoting learners' well-being, inclusive education, and a positive learning environment, DepEd, through the Bureau of Learning Delivery, is currently expanding the conversion of Special Education (SPED) Centers into Inclusive Learning Resource Centers (ILRCs) and planning to commence the construction of new ILRCs for Fiscal Year (FY) 2025.

To achieve the said purpose, this Office is requesting the immediate submission of the following documents:

1. Nomination of one (1) SPED Center with available classrooms for conversion into ILRC service areas as stipulated in DepEd Order No. 45, s. 2021.
2. Nomination of one (1) school with buildable space for the construction of an ILRC, which requires a building footprint of at least 453.88 sqm, land dimensions requirement of 51m (L) by 15m (D) including setbacks of 4.5 m front setback if row (road right of way).

Enclosed is the list of SPED Centers earlier nominated by Regional Offices as recipients of new ILRC Construction for FY 2025. Other Regional Offices are requested to submit their nominees.

Due to its forthcoming deadline for submission to the Department of Budget and Management (DBM), it is requested that all the aforementioned documents be submitted to this Office on or before **April 30, 2024**.
