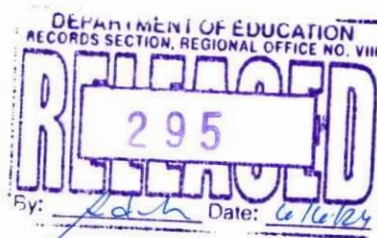
**RESETTING THE CONDUCT OF LABORATORY EXAM OF DEPED RO VIII
