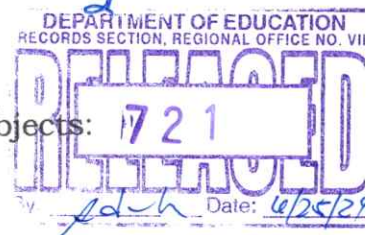

To comply with the requirements of Republic Act No. 11510, also known as the Alternative Learning System (ALS) Act and its Implementing Rules and Regulations (IRR) and in alignment with our commitment to the MATATAG Agenda, particularly to Give support to teachers to teach them better, the Department of Education (DepEd) has issued DepEd Memorandum No. 070, s. 2023 titled Guidelines Provision of Transportation and Teaching Aid Allowances to ALS Teachers and DepEd-engaged Community ALS Implementors Starting Fiscal Year 2022 and Years Thereafter.

The Central Office downloaded funds to the Regional Offices (ROs) for the payment of Transportation and Teaching Aid Allowance for ALS Teachers and DepEd-engaged Community ALS Implementors for Fiscal Year 2024.

To ensure a unified understanding of this issuance, the Bureau of Alternative Education (BAE) will conduct an Online Orientation for Regional, Division ALS Focal Persons and Education Program Specialists II for ALS (EPSII for ALS). This orientation covers the salient features of DepEd Memorandum No. 070, s. 2023, and the computation of the said allowances. This orientation is scheduled from June 25 to 26, 2024 (see attached).
