

- 1.0 This is in relation to the recent approval<sup>1</sup> of the request of DepEd Regional Office No. VIII to directly release the Notice of Cash Allocation (NCA) to the Lower Level Operating Units (LLOUs) for the following specific lump-sum appropriations for Personnel Services (PS) and Maintenance and Other Operating Expenses (MOOE) items for Fiscal Year 2024, to wit:
  - 1.1 Cash Allowance;
  - 1.2 Hardship Pay;
  - 1.3 Reclassification of Positions;
  - 1.4 Terminal Leave Benefits;
  - 1.5 Loyalty Pay; and
  - 1.6 Magna Carta Benefits.
- 2.0 Moreover, this will also include Sub-AROs for Centrally-Managed Items (CMIs), among others.
- 3.0 Anent this, requests should be **directly submitted to DBM by the requesting Schools Division Office or Implementing Units**. (i.e. secondary schools). Likewise, submissions must be made on a **per batch basis** (i.e. every 10<sup>th</sup> and 20<sup>th</sup> day of the month only).
- 4.0 Relatedly, pursuant to DBM Citizen's Charter March 2024 (1st Edition), the following required supporting documents shall be submitted, to wit:
  - 4.1 Special Budget Request (Original copy);

- 4.2 Financial Accountability Report (FAR) No. 1 (Unified Reporting System [URS] –generated and original/certified true copy);
- 4.3 Latest FAR No. 4 (URS-generated and original/certified true copy);
- 4.4 Budget Execution Document (BED) No. 3 (Manually-prepared and original copy);
- 4.5 Computation of Deficiency (Original copy); and
- 4.6 Certified true copy of Sub-ARO.
