- 1. Attached is Memorandum OM-OUOPS-2024-05-04956 dated June 19, 2024 from Atty. Revsee A. Escobedo, Undersecretary for Governance and Field Operations, announcing the national launch of the "Learner Rights and Protection (LRP) on Wheels" initiative that aims to create a safer and more inclusive learning environment for all learners at the beginning of the school year.
- 2. Relative thereto, this Office, through the Education Support Services Division, will lead the regional implementation of the campaign at Leyte National High School on July 29, 2024.
- 3. All Schools Division Offices (SDOs) and public schools are encouraged to feature the LRP on Wheels mobile car/tricycle/tribike during their Brigada Eskwela Kick-off, using tarpaulins of size 3ft x 4ft accessible through this link: https://tinyurl.com/LW-Tarp, and to distribute available social behavioral change (SBC) materials.
- 4. All public and private schools are also enjoined to display banners at their school entrances or other visible areas using designs from these links: https://tinyurl.com/LRPDESKDESIGN and https://tinyurl.com/LRPDESKDESIGN and https://tinyurl.com/MH-Tarp-Design, and conduct classroom-based orientations covering the following topics through panel discussions, art-based activities, roleplay, and simulations:
 - a. How to Spot the "Red Flags" of Bullying
 - b. Anti-OSAEC and Anti-CSAEM: Safer Internet Practices for Learners
 - c. Empowering Learners to Report Learner Rights and Protection Abuse (LRP) Cases to Learners Helpline and Other Support Services
- 5. The Division LRP Focal Persons responsible in the effective implementation of these activities shall attend the virtual coordination meeting on **July 22**, **2024** at 1 p.m. via this link: https://tinyurl.com/R8LRPonWheels.



This has reference to the Memorandum dated May 30, 2024, relative to the Guidelines on the National Implementation of Learner Rights and Protection on Wheels 2024, issued by the Office of the Undersecretary for Operations. Under the aforementioned Memorandum, the Learner Rights and Protection Office (LRPO) will launch the LRP on Wheels as an advocacy campaign program.

In order to provide further support to the Regional Offices in this initiative, this Office issues the following additional guidelines:

Implementation

In accordance with DepEd Order No. 8, s. 2024,¹ titled "Amendment to DepEd Order No. 3, s. 2024, the start of SY 2024-2025 class shall be on July 29, 2024, Monday. Furthermore, as stated in DepEd Order No. 34, s. 2022², the conduct of extra-curricular activities during class hours shall be strictly prohibited. The conduct of in-person extra-curricular activities shall be allowed, provided that these activities are conducted after class hours.

To ensure the strict observance of these guidelines, the LRP on Wheels, as previously scheduled for July 29, 2024, shall now be integrated as one of the initiatives of the *Oplan Balik Eskwela* to expand its reach not only to DepEd Personnel but also other stakeholders, especially the parents and guardians.

Furthermore, if integration into the *Oplan Balik Eskwela* is not feasible, it may be incorporated into other DepEd activities, provided that such incorporation does not disrupt classes and should be conducted within the current school year 2024-2025.

Event Frequency and Duration:

The LRP on Wheels shall be conducted for one week during the OBE or anytime during the school year 2024-2025. It is recommended that the motorcade visit schools, prioritizing those in close proximity, including but not limited to the reported cases received by the Learners Telesafe Contact Center Helpline (LTCCH).

Setup

Each Region will use a mobile unit equipped with resources, including but not limited to tarpaulin, balloons, and educational materials.

The units shall consist of a minimum of five members: one Driver and four LRP Advocates, specifically the Regional Director or Assistant Regional Director, the LRP Regional Permanent and Alternative Focal, LRPO Head and Personnel.

LRP Advocates with trainings on Child Protection Specialization, Psychological First Aid (PFA), and Child Protection Committee Functionality are strongly encouraged to participate in the event of learner rights and protection cases arising, ensuring confidentiality and sensitivity will be maintained at all times, especially when handling sensitive cases.

Mascot Specifications

To strengthen the advocacy program and ensure consistency across all Regions, the Official LRP Mascot as specified in Annex A shall be utilized.

In the event that the Mascot cannot be procured, using a standee for the activity is encouraged as an alternative.

The launch of the LRP on Wheels as an advocacy program is intended to extend outreach efforts, directly engage with schools or communities, and raise awareness about learner rights and protection across various Regions.



Narrative in the specification of LRPO Official Mascot

The mascot symbolizes the Learner Rights and Protection Hotline, otherwise known as the Learners Telesafe Contact Center Helpline (LTCCH). It was established to provide assistance to learners, addressing a wide range of concerns including, but not limited to, abuse, bullying, exploitation, violence, discrimination, and other forms of maltreatment.

Through various communication channels such as email, phone calls, and messenger services, learners can access assistance and guidance in mitigating these scenarios. The concept of the mascot is a chat bubble, signifying open and accessible communication, serving as a reassuring and approachable presence for learners seeking help and support.

Additionally, the mascot's design could incorporate elements that convey trust, empathy, and reliability, aligning with the commitment of DepEd LRPO's mandate in safeguarding the rights and protection of all learners. Thus, it represents hope and support for all learners experiencing various forms of abuse.

- a. The Mascot head is made of polyester with a sturdy poly foam or fiber.
 A breathable mesh designed for clear visibility and printed eyes.
- b. The Headphone Design is made with foam and painted in black and turquoise based on the provided picture above.
- c. Its size is 18 by 18 inches (please see the study for better visualization)

2. Body

- a. The body is foam-padded colored in the same manner as in the study.
- b. Arms, legs, socks, and shoes are made of fabric-finish foam (the supplier must be able to provide technical suggestions if this is possible because of the foam-padded body that may result in a bulky appearance of the mascot.

3. Accessories

- Uniform a fabric attached to the Mascot body, consisting of a white polo shirt with the LRPO logo printed on the right side, and shorts color navy blue;
- b. Belt Obsidian, size 7.5 x 5.5 inches
