This has reference to the conduct of the "Orientation on the Implementation of the Teaching Manual on Children's Rights", the same is in line with Department of Education (DepEd) Order No. 31, s. 2022 or the "Child Rights Policy: Adopting the Rights-Based Education Framework in Philippine Basic Education", which embodies DepEd's strong resolve to respect, protect, fulfill, and promote the rights of children in basic education.

Accordingly, the Learner Rights and Protection Office (LRPO) in partnership with the Geneva Office for Human Rights (GO-HRE) aims to provide an indepth discussion on the developed "Teaching Manual on Children's Rights" providing a clear and achievable activity for teaching our learners about human rights, with emphasis on their corresponding duties and responsibilities as rights-holders.

Relatedly, last April 22 – 25, 2024 the LRPO and GO-HRE conducted the first batch of the Orientation on the Implementation of the Teaching Manual on Children's Rights at Baguio Teachers Camp, Baguio City, during which our participants experienced first-hand the use of the Manual and acquire tools on how to cascade the lessons to our learners.

In line therewith, may we request the regional heads to identify their respective representatives from the region who will serve as participants for

Further, we have allotted three (3) participants per region:


