The activity aims to discuss and differentiate the two structured interviewing processes and come up with an action plan to develop their agency assessment and selection toolkit.

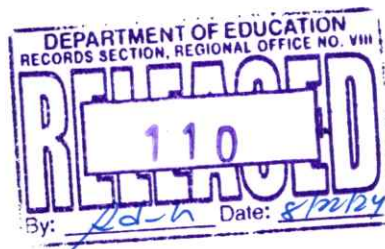

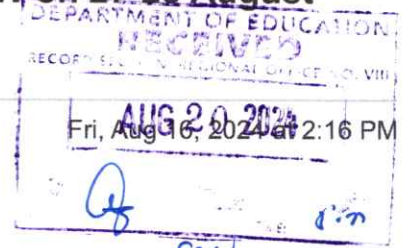

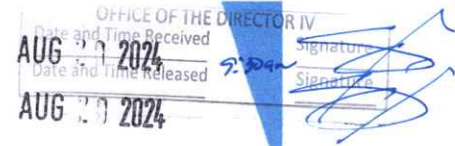

Course Description

This is a two-day course that will enable the participants to apply, practice, develop, install, implement and monitor the evaluation and assessment of potential candidates for a vacant position using structured techniques in the selection process. The structured methods discussed in this online course are Behavioral Event Interviewing (BEI), and Competency-Based Interviewing (CBI) based on objective job-related criteria, and competency requirements, respectively.

Performance Objective

By the end of the two-day course, the participants shall be able to discuss and differentiate the two structured interviewing processes and come up with an action plan to develop their agency assessment and selection toolkit, either for BEI or CBI, depending on the assessment system that is in currently in place.
