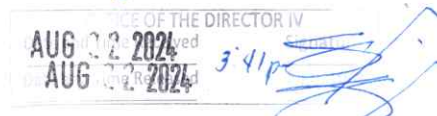
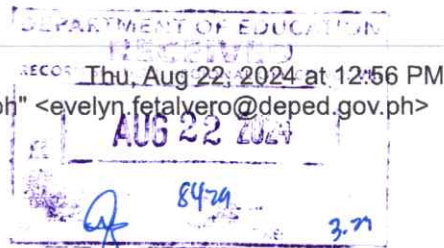

This is in connection with the Knowledge Channel Foundation, Inc.'s Search for The Gurong May K and Kabataang May K.

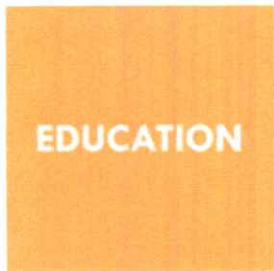
