## ENHANCEMENT OF THE FUNCTIONALITY OF THE CHILD PROTECTION COMMITTEES (CPC)

To: Schools Division Superintendent

All Others Concerned

- Pursuant to the goal of the Learner Rights and Protection Office (LRPO) of ensuring that all learners in the Philippines are protected from violence, exploitation, discrimination, bullying, and other forms of abuse in schools where their right to quality and inclusive education are respected, protected, promoted, and fulfilled, the Department of Education (DepEd) is strengthening the functionality of all child protection committees (CPCs) following DepEd Order No. 40, s. 2012 or the "Child Protection Policy. "
- 2. This Office, through the Education Support Services Division (ESSD) - Special Programs and Projects Section (SPPS), shall conduct the Enhancement of the Functionality of the Child Protection Committees (CPC) on August 26-29, 2024 at a venue to be announced in a separate issuance.
- 3. The activity aims to:
  - a. empower CPCs to perform their function as laid out in DepEd Order No. 40, s. 2012;
  - b. strengthen the CPC in maintaining the protection of learners;
  - c. revisit the functionality of the CPC, which requires fulfillment of the following indicators such as organization and coordination, policies and guidelines, capacities and resources, service delivery, accountability and performance; and,
  - d. plan out ways to advocate the Learners' Telesafe Contact Center Helpline.
