**ALTERNATIVE WORK ARRANGEMENT FOR THE LINKING STANDARDS
AND QUALITY PRACTICE (LISQUP) ONLINE COMPREHENSIVE
EXAMINATION TAKERS**

1. With reference to DepEd Memorandum No. DM-OUHROD-2024-1476, which requests support for the Linking Standards Quality Practice (LiSQuP) online comprehensive examination takers, this Office, through the National Educators Academy of the Philippines-Region VIII (NEAP-RVIII), is requesting the provision of **Alternative Work Arrangements** for the **900 MA and PhD scholars** who will be taking the online exam on **August 17-18, 2024**.
2. The alternative work arrangement shall include the temporary arrangement of their schedule, reducing their teaching workload to ensure that they have adequate preparation in view of the examination's critical nature and importance as a major requirement for the completion of the program.
3. Enclosed is the aforementioned Memorandum, which stipulates the necessary proofs of comprehensive examination qualifications that need to be presented to the school heads prior to agreeing on the alternative work arrangement.
4. The school heads of the concerned teacher-scholars shall ensure that the agreed-upon alternative work arrangement strictly adheres to the *No Disruption of Classes Policy*.
5. Immediate dissemination of and compliance with this memorandum are desired.

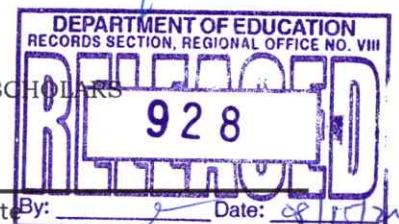

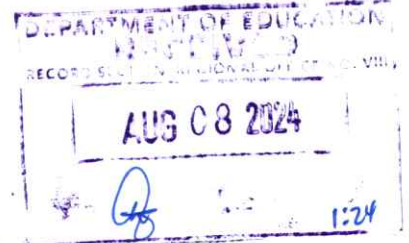

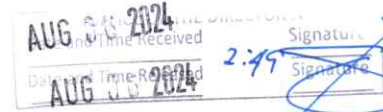

1. This is to inform the Regional Offices (ROs) and the Schools Division Offices (SDOs) that the *Linking Standards and Quality Practice* (LiSQuP) program will conduct an **Online Comprehensive Examination** for **nine hundred (900) MA and PhD scholars** on **17 and 18 August 2024**.
2. In this regard, **ROs and SDOs are requested to provide the necessary support and consideration to the LiSQuP scholars who will take the examination**, by temporarily arranging their schedule and reducing their teaching workload to ensure that they have adequate preparation in view of the examination's critical nature and importance as a major requirement for the completion of the program.
3. The concerned scholars are required to present to their School Heads/Heads of Office the following proofs of comprehensive examination qualification:
 - a. Printed copy of Test Permit;
 - b. Printed copy of the Comprehensive Examination with examinee number;
 - c. Evaluation Form signed by the University Registrar;

- d. Philippine Normal University - LiSQuP notification email (for further verification); and
 - e. Proof of attendance in the Comprehensive Examination (post-exam, as needed).
4. School Heads of the concerned teacher-scholars shall make necessary arrangements to ensure that the *No Disruption of Classes Policy* will be strictly observed. Likewise, Heads of Office of concerned school head/supervisor-scholars shall ensure that office operations and efficiency will not be hampered in the provision of support and consideration.
