CONDUCT OF DIVISION-BASED CAPACITY-BUILDING ON THE IMPLEMENTATION OF QUALITY MANAGEMEMNT SYSTEM

- 1. In reference to Regional Memorandum No. 255, series 2024, Capacity-Building on the Implementation of the Quality Management System (QMS) for Schools Division Offices, and DepEd Order No. 009, series 2021, Institutionalization of a Quality Management System in the Department of Education, this Office hereby directs all Schools Division Offices (SDOs) to conduct Division-Based Capacity-Building on the Implementation of Quality Management System.
- 2. Participants who attended the regional training held on August 13-16, 2024, shall serve as facilitators for the division-based training in their respective SDOs.
