- 1. To reinforce our commitment to protecting learner rights and in compliance with Republic Act No. 11313, known as the "Safe Spaces Act," and Republic Act No. 11188, the "Special Protection of Children in Situations of Armed Conflict Act," the Department of Education issued Memoranda Nos. OUOPS-2024-05-01115 on February 7, 2024, and OM-OUOPS-2024-05-00167 on February 13, 2024, which provided guidelines for implementing the aforementioned laws in Basic Education.
- 2. This Office, though the Education Support Services Division (ESSD) Special Programs and Projects Section (SPPS), shall conduct the **Orientation on the DepEd Guidelines of the Safe Spaces Act and Protocols for Handling Children in Situations of Armed Conflict** on October 23-25, 2024 at a venue to be announced in a separate issuance.


