**DOWNLOADING OF PROGRAM SUPPORT FUNDS FOR THE TRANSPORTATION
EXPENSES OF MATERIALS OF THE NATIONAL ASSESSMENT OF
BASIC EDUCATION (NASBE)**

To: Schools Division Superintendents
All Others Concerned

1. This Office, through the Curriculum and Learning Management Division (CLMD), shall download funds to the 13 SDOs to cover the travel expenses/transportation of the materials including their retrieval.

2. The fund is a continuing fund as indicated in the Sub-Allotment Release Order (SARO) attached herein. Any excess or unused funds may be used to pay expenses incurred in the implementation of previous and succeeding education assessments being administered by the Bureau of Education Assessment (BEA) such as:

- a. Early Language, Literacy, and Numeracy Assessment (ELLNA);
- b. National Achievement Test (NAT) for Grades 6,10, and 12;
- c. National Career Assessment Examination (NCAE);
- d. Philippine Educational Placement Test (PEPT);
- e. Accreditation and Equivalency (A & E) Test;
- f. Qualifying Examination in Arabic Language and Islamic Studies (QEALIS), and/or; and
- g. National Learning Camp Assessment (NLCA).

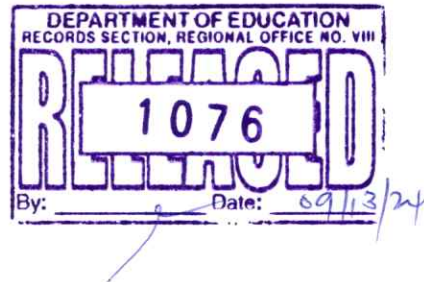
