NATIONAL LITERACY AWARDS (NLA) FINALIST**

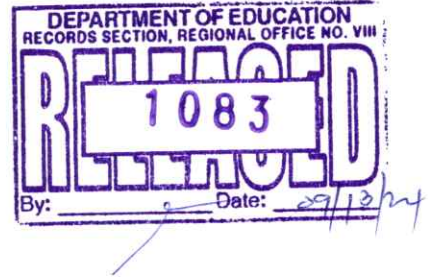
