- 1. To ensure efficient and successful implementation of the MATATAG Curriculum, DepEd programs and projects, curriculum contextualization in all learning areas including ALS and the LRMDP, and the distribution and utilization of the various LRs, this Office, through the Curriculum and Learning Management Division (CLMD) and Learning Resources Management Section (LRMS), shall conduct the Monitoring for Calendar Year 2024 2026.
- 2. The activity aims to:
 - a. monitor and assess the status of distribution and utilization of regionally-procured SLRs, SLMs, and Learning Tools and Equipment in Science and Math Equipment (SME) and Technical-Vocational Education (TVL) in the schools;
