In case the downloaded funds are not enough to cover these expenses, the local funds of the participants may also be used for reimbursement of travel.
- 4. Should the activity also fall on a holiday and/or a weekend, participants who are DepEd employees are eligible to earn compensatory time-off (CTO) in accordance with DepEd Order No. 53 s. 2003 or the Updated Guidelines on Grant of Vacation Service Credits to Teachers and DBM-CSC Joint Circular No. 2, s. 2015 or the Policies and Guidelines on Overtime Service and Overtime Pay for Government Employees.
- 5. Immediate dissemination of and compliance with this Memorandum are desired.
