IMPLEMENTATION OF THE JOINT DELIVERY VOUCHER PROGRAM (JDVP) FOR THE SCHOOL YEAR 2024-2025

To: Schools Division Superintendents
All Others Concerned

- 1. This Office, through the Curriculum and Learning Management Division (CLMD), announces the implementation of the Joint Delivery Voucher Program (JDVP) for the School Year 2024-2025, from November 4 to December 13, 2024.
- 2. The primary objective of the program is to enhance the capability of DepEd Senior High Schools (SHSs) to implement the TVL track through partnership with partner institutions that are equipped with necessary resources to carry out the program. Specifically, the JDVP-TVL aims to:
 - enable learners to complete their respective TVL specialization subjects through the JDVP-TVL Partners;
 - b. provide an appropriate learning environment required of the specialization; and
 - address delays in the provision of the necessary resources for TVL specializations.
- 3. The allocation of JDVP slots for SY 2024-2025 is based on the budget allotted in the GAA to the JDVP. The number of slots allotted to the respective implementing divisions is presented in the table below:

- 4. To complete the required 320 hours or 40 days of TVL specialization training for School Year 2024-2025, Blended Learning Modality will be utilized, which includes Face-to-Face training on weekdays, and Modular Approach on Saturdays and Sundays from November 4 to December 13, 2024.
- 5. The JDVP DepEd implementing schools shall manage on how the SHS TVL students enrolled in the program can still comply with the other subjects while engaged in the TVL specialization training.
- 6. A convergence of JDVP Division Focal Persons, School Coordinators, representative of the Partner Institutions with the CLMD and select Quality Assurance Division (QAD), and Education Support Services Division (ESSD) personnel shall be conducted on October 21-23, 2024, in Ormoc City, to be hosted by the Divisions of Biliran and Ormoc City. The specific venue will be announced on a separate Regional Advisory.
- 7. Travelling and other incidental expenses incurred shall be charged against the local funds / MOOE subject to the usual government accounting and auditing rules and regulations.
