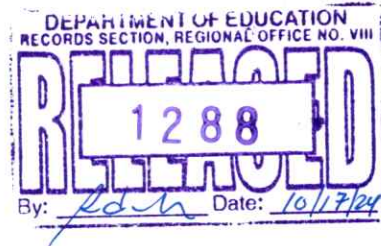

The activity aims to:

- share updates and best practices on the implementation of the Special Program in Foreign Language;
- discuss innovations, trends, and challenges and opportunities in foreign language education;
- discuss action plans and other ways forward for the sustainability, growth, and improvement of the Program; and
- promote intercultural understanding and appreciation.

With the theme *“Navigating the Evolving Foreign Language Education Landscape: Perspectives, Praxis, and Prospects,”* the conference will convene the program partners of the foreign languages offered under the SPFL (Chinese, French, German, Japanese, Korean, and Spanish) and representatives from field implementers nationwide.
