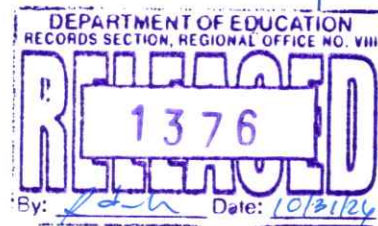

This has reference to the Development of Positive Discipline (Pos-Di) Learning Action Cell (LAC) Session Guides by the Learner Rights and Protection Office (LRPO) and the Bureau of Learning Delivery-Teaching and Learning Division (BLD-TLD).

Pursuant to the DepEd Order No. 40, s. 2012 or the "DepEd Child Protection Policy", which prohibits the use of corporal punishment and instead uses positive and non-violent approach to discipline<sup>1</sup>, LRPO together with the BLD-TLD crafted the session guides to strengthen the use of positive discipline as a behavioral management technique in schools. The LAC Session Guides have undergone consultation and review, it has integrated all learner protection policies, including theories on the importance of discipline in schools.

The development of which began with identifying the seasoned writers from the different regions to assist in the crafting of the modules. These writers have undergone training in different learner protection policies and their possible integration into the different theories and teaching methodologies using positive discipline.

At present, the LAC session guides have been finalize and an initial orientation will be conducted, in line with this, we hope to invite the following DepEd personnel
