**THE VISIT OF DEPED SECRETARY SONNY ANGARA

GIRLS' EDUCATION CENTER (GEC)**

1. As part of our collective effort to prepare for the **Visit of Honorable Senator and Secretary Sonny Angara and Team to the Girls' Education Center (GEC)**, this Office, through the Curriculum and Learning Management Division (CLMD), requires the Schools Division Offices (SDOs) of Leyte and Tacloban City to send their respective Division Alternative Learning System (ALS) focal persons, Education Program Specialists for ALS, and teachers who are involved in the implementation of the project "**Better Life**", on **November 7-8, 2024** at the GEC, DepEd Regional Office VIII, Palo, Leyte, to prepare the physical setup of the center.

3. November 8, 2024 is a local holiday and November 9-10, 2024 fall on a Saturday and Sunday; thus, Job Order (JO) employees will receive the appropriate daily compensation, while regular employees will be granted equivalent Compensatory Time-Off (CTO).

All Division ALS focal persons across Region VIII are invited to be present at the GEC on **November 11, 2024**, to join in welcoming Honorable Secretary Sonny Angara and his team during their visit. The attire for the event is Barong Tagalog for males and Filipiniana for females. The presence of **Mr. Ronnie Paloma** from the Baybay City Division is requested to handle the documentation of the visit.
5. Snacks and lunch for the division participants will be arranged by the DepEd Regional Office, through the CLMD-ALS, while their travel and incidental expenses, shall be charged against the ALS/Local/MOOE Funds at the respective offices, subject to the usual accounting and auditing rules and regulations.
