

With the submission of Fiscal Year (FY) 2025 National Expenditure Program (NEP), and in accordance with the DepEd Memorandum No. 049, s.2024 on the Conduct of Fiscal Year 2025 Early Procurement Activities by the Central, Regional and Schools Division Offices, this memorandum is issued to establish the guidelines on the conduct of Early Procurement Activities (EPA) for the FY 2025 Computerization Program.













Regional Offices (ROs) shall initiate EPA short of award to ensure timely deployment of DCP for CY 2025. It must be noted that contract shall be awarded only upon the approval of the General Appropriations Act (GAA) and shall comply with the existing rules and regulations pertinent to the updated 2016 Revised Implementing Rules and Regulations (IRR) of the RA 9184.


In view of this, we are respectfully transmitting the Updated Guidelines on Regional EPA for DCP FY 2025 as of 13 November 2024. All pertinent documents can be accessed through this link https://tinyurl.com/REPADCP2025.


The use of funds shall be subject to existing government budgeting, accounting, auditing, and procurement rules and regulations.

RPO Fund Utilization

- Any excess amount or balance from the fund allocation, specifically the savings
 due to lower bid offers/prices vis-a-vis declared ABC, may be used for the
 procurement of goods, or for any program-related expense subject to existing
 government budgeting, accounting, auditing, and procurement rules and
 regulations within the fund year.
- 2. In the use of such excess amount or balance, appropriate method of procurement shall be used pursuant to the relevant rules and regulations.

Minimum Technical Specifications

- 1. The RPOs shall refer to the specifications included in these guidelines.
- 2. RPOs can upgrade or improve the specifications provided that:
 - a. the minimum specifications are met;
 - b. an appropriate market study is conducted;
 - c. the total number of devices is not reduced; and
 - d. the total amount does not exceed the budget ceiling, per the *Indicative Regional Physical and Financial Allocation*.
- In addition to the specifications included hereunder, the included clauses in the associated Terms of Reference are made an integral part of the minimum technical specifications.
- 4. The specifications for Laptops and Smart TV were originally vetted by the Department of Information and Communication Technology (DICT) and have been modified in this memorandum to enable greater market participation and make consistent the various brand prerequisites.
- 5. Regarding supporting documents and other proofs described under these specifications, these should form part of the bidder's bid, specifically under Technical Documents for the Technical Component Envelope.
- 6. In the event that a brand reference is used (e.g. "Windows", "Microsoft", etc.), the law carves out an exception.
 - a. Pursuant to Sec. 18, IRR of RA 9184 (2016), "Specifications for the procurement of Goods shall be based on relevant characteristics, functionality and/or performance requirements. Reference to brand names shall not be allowed <u>except</u> for items or parts that are compatible with the

existing fleet or equipment of the same make and brand, and to maintain the performance, functionality and useful life of the equipment.

This Section shall also apply to the goods component of Infrastructure Projects and Consulting."¹
