**ONLINE TRAINING FOR BREACH RESPONSE AND CYBER SECURITY
BY YISRAEL SOLUTIONS AND TRAINING CENTER, INC.**

3. Obtain insights on the different phases of security threats: System Hacking, Malware Threat, Sniffing, Social Engineering, DDOS Attack, and how they can respond to them.

The target participants are Data Protection Officers (DPOs) or individuals holding similar roles, such as Information Security Officers, Compliance Managers, or IT Security Specialists, who are responsible for overseeing and ensuring the protection of sensitive data and maintaining the security of organizational information systems. These professionals play a key role in managing data privacy risks and implementing effective security protocols to safeguard against potential threats.

Participation of both public and private schools shall be subject to the *no-disruption-of-classes policy* stipulated in DepEd Order No. 9, s. 2005 entitled *Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith*.

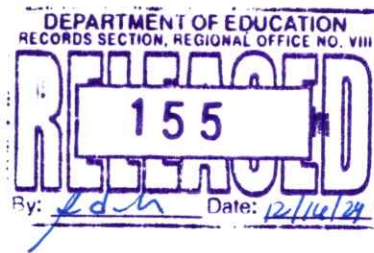
