**REGIONAL FEDERATED SSLG AND SELG FEDERATED  
ELECTIONS AND LEADERSHIP TRAINING 2025**

1. The Regional Federated Supreme Secondary Learner Government (SSLG) and Supreme Elementary Learner Government (SELG) Elections and Leadership Training shall be conducted on August 17-20, 2025 at the RELC-NEAP, DepEd Regional Office VIII, Government Center, Candahug, Palo, Leyte. This activity is anchored on the theme: **Empowered Voices, Enlightened Leaders.**
